WS-001	Workplace Safety	Educate: staff, volunteers, coaches, learning facilitators on hygiene, sanitation, social distancing, maximum number of members, signs and symptoms of COVID19, sanitization routines, and the impact of preventing the spread of communicable diseases.
WS-002	Workplace Safety	Club PFDs should be assigned to an individual sailor for the duration of public health measures and kept separate from other equipment and brought home.
WS-003	Workplace Safety	Establish a communication plan to keep staff, volunteers, coaches, learning facilitators, volunteers informed and updated on issues affecting the workplace.
