

# 2025 Canada Summer Games Selection Trials

### Intent

Registration by the athlete in any event in the qualifying series confirms an athlete's intent to participate and desire to be considered for selection.

## Age Eligibility

To be eligible for consideration, athletes must be under 20 years of age and no younger than 15 years of age as of December 31, 2025. Eligible athletes must have a date of birth between January 1, 2005 - December 31, 2010.

### **Eligible Events**

### Male Categories:

- Singlehanded ILCA6
- Doublehanded 29er

### Female Categories:

- Singlehanded ILCA6
- Doublehanded 29er

## Qualifiers

Qualifier events for the ILCA 6 class will be as follows:

# **Qualification Rules**

## Eligibility

To be eligible for consideration, athletes must meet the selection criteria as outlined in the Canada Summer Games Technical Package and Athlete Eligibility Policy:

- The 2025 Canada Summer Games Sailing Technical Package
- Athlete Eligibility Policy

In addition to the outlined Canada Summer Games technical and athlete eligibility requirements, athletes will also need to meet the following requirements set out by Sail Manitoba:

- Competitors must be members of a Sail Manitoba Affiliated Yacht Club and Sail Manitoba/Sail Canada to compete in the qualification events. Competitors do not have to be members of the Manitoba Sailing Team to be eligible for selection.
- Athletes must be in good standing with Sail Manitoba and their home club.
- Athletes must be Canadian citizens or permanent residents.
- Athletes must be residents of Manitoba

### **Racing Rules**

The qualifying regattas will be conducted according to the Sailing Instructions of the events as prepared by the host yacht club and its race committee.

### Athlete Qualification

Athlete qualification will be completed through a series of four qualifier events, which will be scored based on a relative placement lowest score system. Example:

- An athlete that places 3 out of 10 boats in the event will earn a score of 0.3 (3 divided by 10) towards the qualifier series.
- An athlete that places 14 out of 20 boats in the qualifying event will earn a score of 0.7 (14 divided by 20) for the qualifier series.

Points will be awarded based on a competitor's placement at each qualifying event within their respective class. Athletes that do not participate in a qualifying event will automatically receive a score of 1.1 (representing last plus 1 position).

At the end of the qualifying series, points received for each event will be added together to determine overall score in the series. Each participant will be eligible to drop their worst score amongst the four qualifiers. Ranking of athletes seeking to qualify will be determined on a lowest score system within each class.

In the event of a tie, the boats will be ranked by the number of times they scored better than the other tied boats. The highest-placed competitor or boat will qualify first, and the next-placed competitor or boat will be named the alternate.

Should there be no eligible Manitoba athlete(s) at the selection competition, the committee may select an athlete from the current eligible athletes. If a selected athlete withdraws by informing Sail Manitoba in writing, then Sail Manitoba may appoint the 2<sup>nd</sup> highest finisher at the selection competition.



## Athlete Selection

Athletes named to Team Manitoba's Canada Summer Games Sailing Team must join the Manitoba Sailing Team as a High-Performance Team Member. Training with the team as well as attendance at all agreed-upon team events ahead of Canada Summer Games is mandatory to retain an athlete's spot on the team.

If an athlete cannot participate in the designated training program or events, a request must be made to the Head Coach stating the reason and showing a detailed training plan for the competition leading up to the Canada Summer Games.

In the event that a named athlete choses to withdraw from the Canada Summer Games and the Manitoba Sailing Team, they will need to inform the President of Sail Manitoba by email at <u>sailing@sportmanitoba.ca</u> as soon as possible.

# Appeals

Appeals for the Qualifiers will be accepted up to seven days after the announcement of the 2025 Team Manitoba Athletes and to be submitted to the President of Sail Manitoba by email at <u>sailing@sportmanitoba.ca</u>.

The Appeals Committee will be comprised of one of each of the following:

- President of Sail Manitoba
- Executive Director of Sail Manitoba
- Provincial Sailing Coach(es)
- A certified Sail Canada Race Official (Race officer or Judge)

In the event that an athletes is unsatisfied with the findings of the Appeal Committee, they may appeal to the Sport Dispute Resolution Centre of Canada (SDRCC) for an additional assessment. SDRCC will review the case and make a final decision on the appeal. Any costs incurred by appealing to the SDRCC will be borne by the athlete.
